Privacy Policy Overview

This privacy policy explains how Debbie Wren Counselling manages personal information provided by clients. I am committed to protecting your privacy by adhering to the Australian Privacy Principles outlined in the Privacy Act 1988 (Cth).

Personal and Sensitive Information

Methods of Collection

- Intake forms
- Social media
- · Guardians of clients under 18 years old
- Referrals from GPs or other practitioners

Storage and Security of Personal Information

I use secure methods to store both paper and digital records, accessible only by myself. Credit card and banking details are not kept after payment is processed. Unnecessary information is securely disposed of periodically, in line with legal requirements. Should a security breach occur, I will investigate promptly and notify affected individuals as required by the Privacy Act.

Disclosure of Personal Information

I do not share your personal information with third parties without your consent, unless required by law. Disclosure to recipients outside Australia is highly unlikely.

Access to Personal Information

You may request access to your personal information at any time. Requests are handled in accordance with the Privacy Act, and access may be refused in cases permitted by law.

Updating Your Information

I strive to ensure the accuracy and currency of the information I hold. If you believe your personal details are incorrect, you may request a correction, and I will respond as required by the Privacy Act.

Complaints

If you believe your personal information has been mishandled, please contact me first so I can investigate and seek to resolve your concern.
